IMPORTANT INFORMATION- By Consenting To This Program, You Are Agreeing To The Information Below.

- 1) **A permit is required by June 22, 2018 to participate in the program.**
- 2) The summer program will run from June 25th through August 10th.
- 3) **Fee for the program is \$580.00.** Please make check payable to **Eastchester Union Free School District** and submit it with the completed application, **signed by a parent or guardian**. Submit to the **Technology office located on the 2nd floor of Eastchester Middle School or mail to 550 White Plains Road, Eastchester, NY 10709 (Attn: Lisa Balsamo, Drivers Ed).**
- 4) Payment is required with the application. After 1 week from the start of the program, no refunds will be issued. Withdrawal from the course must be done within the first week.
- 5) Course requirements and assignments will be provided at the mandatory 90-minute **ORGANIZATIONAL MEETING WHICH WILL BE HELD ON MONDAY, JUNE 11TH AT 6:00 PM IN THE EASTCHESTER HIGH SCHOOL AUDITORIUM. A PARENT SHOULD ATTEND WITH THE STUDENT.**
- 6) Driving instruction is provided by PAS Auto School (914) 332-7700.
- 7) **Students must complete all requirements by the end of the session which includes all driving/ in-car sessions and lecture classes.** Any extenuating circumstances that prevent the completion of the course will be reviewed for disposition by the Eastchester Driver Education Program. The inability of a registered student to complete the Driver Education program on time, for any reason, does not obligate the Eastchester Driver Education program or PAS Auto school to provide refunds or additional classes to complete the course.
- 8) Any Certificates of Completion which need to be reissued will incur a \$50.00 processing fee.

For Students To Be Better Prepared:

Prior to the start of the Driver Education Program, students should have some driving experience with a supervising driver age 21 or older who has a valid Driver’s License to operate the vehicle the student is driving.

Eastchester High School’s Driver Education Summer Attendance Policy

The New York State Education Department requires that each student attend 24 hours of classroom instruction and 24 hours of in-car instruction. A passing grade on both the classroom lecture classes and the in-car instruction is required to successfully complete the driving program.

Failure to meet the 24 hours of classroom and 24 hours of in-car requirement will result in course failure and denial of your MV-285 (Completion Certificate) and insurance certificate.

Work, vacations and extracurricular activities are not acceptable excuses for missing your driver education lecture class or in-car session (driving and observation session).

- A maximum of two absences (2 lecture classes and 2 in-car session) are allowed but must be made up.
- More than two absences may result in failure from the program.
- All **lecture** absences to be made up must be scheduled with the lecture teacher and completed within the summer program.
- All **in-car** absences must be scheduled for makeup with PAS Auto School and completed within the summer program.
- All makeups, lecture and in-car sessions, must be completed by the end of the Driver Education Program you are enrolled in.
- Refunds will not be issued.
- Makeups extending into the next Driver’s Ed Program will be at the discretion of Eastchester Driver Education Program and PAS. A fee of \$45.00 per lecture and in-car session will be charged for each make up.

***Again, if lecture and driving absences are not made up and completed by the end of the program you are attending, you automatically fail the program.**
